- live online class, starting in January 2018*

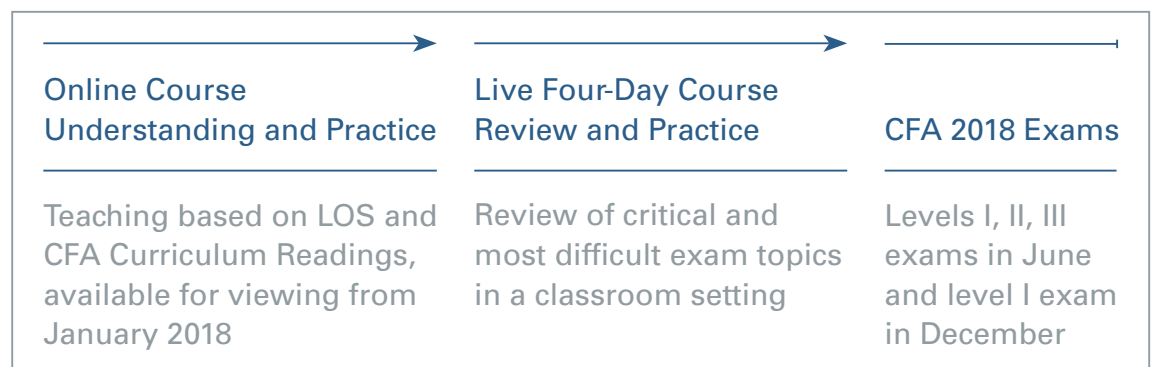
For the level I December 2018 exam we are offering the following courses:

Learning Approach

The online courses cover the exam relevant topics of the CFA curriculum and are structured in accordance with the Learning Outcome Statements (LOS). The online sessions offer comprehensive and detailed coverage of the exam material and help candidates to strengthen their understanding of difficult concepts. For candidates wishing to review and practice the critical and most difficult exam topics in a classroom setting, a live four-day intensive review course is also offered in Zurich.

Online Courses for Levels I, II and III

The recorded online courses are available for viewing from January 2018 until exam date. Start is possible anytime. The online program offers candidates both flexibility and a structured approach to their exam preparation. The classes are archived enabling candidates to review lectures as many times as they wish.

The recorded online classes offer the following features:

- More than 60 hours of teaching given by experienced CFA lecturers.
- Downloadable handouts which contain all the Learning Outcome Statements (LOS), corresponding concepts, and exam-type questions. These handouts are a summary of the CFA curriculum and can be used as a supplement to the Curriculum Readings.
- Unlimited access for one user to archived online classes available until exam date. CFA classes can be attended anywhere, anytime.
- Online forum to exchange questions with lecturers.

Four-day Courses for Levels I, II, and III in Zurich

In the four-day intensive review courses the critical and most difficult exam topics will be explained and practiced with exam-type questions. The live four-day courses are split into two sessions of 2 days (Friday/Saturday) allowing course participants to digest better the vast amount of course material covered. The Curriculum Readings of CFA Institute (and/or any summary of the Curriculum Readings such as the Schweser Study Notes) can be used to prepare for the intensive review course. To support the study phase leading up to the intensive review course, CfBS recommends its online course for an efficient and effective preparation.

Online access to recorded classes: The live four-day intensive review course will be recorded, allowing course participants to revisit online all the topics explained in class.



Study Material

Teaching/studying is based on the following materials:

- Curriculum Readings of CFA Institute which are included in the examination fees.
- As a supplement to the Curriculum Readings: comprehensive handouts developed by CfBS which contain all the Learning Outcome Statements, corresponding concepts, and exam-type questions.

In order to prepare for the online and/or four-day courses students should read the Curriculum Readings and/or any summary of the Curriculum Readings such as the Schweser Study Notes. During the lessons CfBS will use its own study material to explain and practice the concepts. This approach ensures that the material is presented from a different angle and that students receive maximum added value.

The CfBS handouts are a summary of the CFA curriculum and can be used to efficiently review the curriculum in the final stages of the exam preparation.

Calculator

CFA Institute only allows the following two calculators at the exams: Hewlett Packard 12C and Texas Instrument BAII Plus. These can be purchased from www.taschenrechner.ch or in specialised shops. Both calculators will be explained and used in the CfBS exam preparation courses.

Course Fee for Online Courses

The course fee amounts to CHF 990.–. This includes unlimited access to archived online courses for one user and downloadable handouts (summary of CFA curriculum and exam-type questions). Together with the live four-day intensive review course the fee amounts to CHF 2,400.–. The Curriculum Readings of CFA Institute are included in the registration fee for the CFA exam.

Course Fee for Four-day Courses

The course fee for level I amounts to CHF 1,450.–, while the course fee for levels II and III amounts to CHF 1,650.–. This includes CfBS handouts (summary of CFA curriculum), question sets, and online access to the recorded four-day course. Combined with the online course the fee amounts to CHF 2,400.–. The Curriculum Readings of CFA Institute are included in the registration fee for the CFA exam.

Registrations can be cancelled up to the end of the registration period. After this deadline the full amount is due.
